General terms and conditions of sales

ORDER

Any order placed is only valid if confirmed by return mail or email with the note "Approved", the date, the customer's name, and the chosen payment method (attach bank details in case of payment by bill of exchange). The "Approved" note constitutes acceptance of the General Terms and Conditions of Sale. Reductions in ordered quantities are only possible until January 15 of each year. After this date, the order will be invoiced in full, unless expressly agreed otherwise.

APPLICABLE RULES

the present sale is governed by these General Terms and Conditions of Sale and by the RUCIP rules and practices, latest edition, in all provisions not contrary to these terms. The buyer declares being familiar with all rules and practices of the Inter-European Potato Trade as well as the Expert Assessment and Arbitration Regulations established under the RUCIP code. All disputes shall be submitted in France to the RUCIP Arbitration Commission based in Paris, which is expressly agreed as the sole place and body of arbitration, and shall be exclusively competent for arbitration at both first and second instance. In the event of a conflict between the applicable General Terms and Conditions of S.C.I.C. DOUAR DEN/BIO-PLANTS and the RUCIP rules, the General Terms and Conditions of S.C.I.C. DOUAR DEN/BIO-PLANTS shall prevail.

EXECUTION OF SALES

Our goods comply with the provisions of the applicable decrees and regulations. Any damage, waste, risk of frost, or shortages during transport shall always be borne by the carrier.

CLAIMS

Any dispute relating to our sales, regardless of the reason, must be sent to us by post or email within 48 hours of the delivery date, failing which it shall be considered null and void. The time limits for claims are governed by the provisions of Article 28 of the RUCIP rules and practices. Any claim concerning seed potatoes must be made before planting and will only be accepted if the goods have been properly received and stored.

Upon receipt of the goods, the buyer must provide a clean, ventilated area protected from frost. It is understood and accepted as a special condition that climatic conditions, soil type, cultivation practices, storage conditions, etc., have a decisive and predominant influence on the results. DOUAR DEN declines all responsibility for any losses the client may incur. Under no circumstances may compensation exceed the value of the goods. Delivery times are given for information purposes only. Delays in delivery shall not give rise to penalties, compensation, or cancellation of the order, nor to claims for damages.

All claims must be accompanied by certificates of origin, delivery notes, and waybills. In the event of damage to the goods during transport arranged by DOUAR DEN, the claim must be noted on the waybill in the presence of the driver. The client must take photos of the goods and send them to us on the same day of delivery.

PAYMENT

Unless otherwise specified, our goods are payable to S.C.I.C. DOUAR DEN/BIO-PLANTS upon receipt of the seed potatoes (for payments by cheque or bank transfer), or within 30 days end of month from the delivery date (for payments by bill of exchange). For any order, a total or partial advance payment may be requested. The order will only be validated once this payment has been cashed. No discount will be granted for early payment.

Acceptance of an order is subject to the buyer's proven solvency. DOUAR DEN reserves the right, in case of doubt about solvency or in the event of a dispute with the other party, to require full payment upon order. Any deterioration in the buyer's financial situation, regardless of the cause, shall immediately trigger the requirement of cash payment.

In the event of non-payment within the agreed time:

- penalties at three times the legal interest rate,
- a fixed compensation of €40 for recovery costs,
- will automatically apply. Interest will accrue from the date of formal notice. Penalties and interest are legally due and will automatically be charged to the buyer's account. Non-payment will also result in the suspension of any new deliveries until all outstanding sums are settled.

Any party wishing to obtain an invoice exempt from VAT must provide DOUAR DEN with one of the following: the DAU (Single Administrative Document), the CMR endorsed by all parties involved, or a tax certificate from the authorities authorizing VAT-free purchases. If this requirement is not met, DOUAR DEN will apply VAT at the legal rate in force.

RETENTION OF TITLE

S.C.I.C. DOUAR DEN/BIO-PLANTS retains full ownership of the goods sold until full payment of their price, in accordance with the provisions of the law of May 12, 1980 and all subsequent regulations. However, the client shall bear, from the time the goods leave our premises (in case of collection) or at the moment of delivery (in case of transport arranged by DOUAR DEN), all risks of loss or deterioration of the goods as well as any damages they may cause.

JURISDICTION

In accordance with Article 31 of the RUCIP rules and practices, all disputes arising from this contract shall be settled by the RUCIP Arbitration Court in Paris, which shall have sole jurisdiction at both first and second instance. By express agreement, the parties also recognize the exclusive jurisdiction of the Commercial Court of Saint-Brieuc, whether in substantive proceedings, summary proceedings, or injunctions, for disputes relating solely to the payment of invoices, including principal, fees, interest, and ancillary costs. RESTRICTED HARVEST CLAUSE

All sales by SCIC DOUAR DEN are subject to the quality and yield of the harvest. If, due to an unsatisfactory harvest in terms of quantity or plant quality – including rejections by the competent authorities – fewer products are available, DOUAR DEN reserves the right to adjust the orders placed accordingly.
